

ReSAF (RESEAU E-SANTE EN AFRIQUE FRANCOPHONE) GOVERNANCE TOOL

Design Date: 20 July 2022

I. Context and rationale

Faced with the challenge of combatting COVID-19, maintaining access to essential health services and continuing to ensure the achievement of the Sustainable Development Goals (SDGs), governments have urgently called for data governance and data sharing.

Transform Health, a coalition of more than 50 organisations, has been working to strengthen health systems to meet the immediate challenges posed by facing up to events such as COVID-19 by harnessing digital technology and the use of data. On 23 May 2022, Transform Health, Speak Up Africa and the Baobab Institute established a regional network in West Africa based on inter-organisational coordination to support health services in achieving universal health coverage.

The network's governance structure is made up of different working groups, which represent specific sectors. Coalition partners will work together to achieve this by leveraging their networks, knowledge, collective influence and engagement with donors, governments and multilateral institutions to ensure an appropriate enabling environment through:

- Improved regulations, legislation, governance and management structures, and funding at national level;
- Effective regulation of health data through the creation of a global health data governance framework, endorsed by governments through a World Health Assembly resolution;
- More and better coordinated and aligned funding to accelerate inclusive, equitable and sustainable digital transformation of health systems in low and middle income countries.

- Participate in regional efforts to systematise the inclusive and efficient digitalisation of health services to achieve universal health coverage.
- Strengthen, amplify and disseminate the efforts of existing stakeholders in the field of digital health in Africa.
- Promote the positive effects and impact of digital health to stakeholders.
- Facilitate relations and negotiations with the players in the ecosystem (private, public and parapublic) to find sustainable business model solutions that will allow the optimal implementation of the digital health strategy
- Participate in regional and global dialogue around the regional, national and institutional imperative of good health data management

IV. Governance structure

The network operates under a network governance model that relies on inter-organisational coordination to achieve its goals, mission and vision (this model is explained in more detail in the <u>coalition strategy paper</u>). The network's governance structure is made up of different working groups, as follows:

- Promote the smooth functioning of the technical committee and the thematic working groups on digital health, as well as cross-sectoral cooperation between ICTs and health.
- Take part in risk management and challenge resolution.

V. The value of a partnership with RESAF

ReSAF is a multi-stakeholder platform that offers members the opportunity to collaborate on a range of matters that will enable the coalition to increase its influence on key stakeholders. It offers tangible benefits to its members, including:

- First meeting of the steering committee to develop a 2022 roadmap (August 2022):
- Strategic communication and advocacy opportunity on and for the network in 2022
- Set up the work groups
- Methodology to implement an annual work plan for the network (to launch in 2023)
- Geographic (2 countries) and thematic focus (per year)
- Working group established as "Lead" in 2023
- Work plan that would build on global, regional and national forums and opportunities for consultation, reflection and coordination (World Health Days, Forum/Webinars/Coalition Members and Partners Conferences, etc.)
